More than 10,000 job seekers had braved an agonizing hot day lining up for interviews at the national stadium not knowing that the jobs will be frozen after local media reported that 29 out of the 70 may not have been recruited on merit but rather from what <u>The Citizen</u> newspaper called "their right connections". This shows how serious unemployment problems are in Tanzania. The government quickly shelved the employment offers pending an investigation into alleged nepotism.
